**FIRING WILL COMMENCE AT 9:00 a.m.**

**RULES:** Current NRA rules will govern the conduct of the match. (Pertinent NRA rules will apply for use of electronic targets, when available.)

**ELIGIBILITY:** NRA membership is not required to compete in NRA sanctioned matches, although it is strongly encouraged.

**RIFLES ALLOWED:** Target Rifle - Rule 3.3.5; International Target Rifle Rule 3.3.6; F-Class Rifle - Rule 3.4 (a) F-Open, (b) F-TR ; No compensators or muzzle brakes allowed – Rule 3.16.1

**TARGETS:** MR1/FC as appropriate. (Electronic targets will be used)

**CLASSIFICATION:** NRA Fullbore classification cards, or temporary score books are required. Competitors who do not currently hold an NRA Fullbore classification but who do hold an NRA classification in another NRA High Power Rifle discipline will be assigned a temporary Fullbore classification based upon their other NRA High Power Rifle Classification. See Rule 19.6.

**CATEGORIES:** Minimum of 5 shooters required to form a class/category.

**SQUADDING:** At Statistical Office commencing at 8:00 a.m.

Prepaid entries will be squadded first. Entries made by telephone cannot be guaranteed.

Competitors are required to check in by 8:45 a.m.

Entries end at 8:50 a.m. the day of the match and are restricted to the first 36 paid competitors.

**GENERAL:** The Match Director is authorized to reduce the match in shots fired or distance due to range conditions. Refunds will not be provided once the match has commenced.

**IMPORTANT NOTES:**

A **FIVE MINUTE** non-firing preparation period will be provided at the start of each match. No equipment will be allowed on the firing line until the preparation period begins.

Competitors must remain in the prone position until all on their target have completed the shoot. They may then retire from the firing point, after completing their register keeping duties and rifle safety checks, provided they do not disturb competitors who are still firing on adjacent targets.

A strict time limit of 34 minutes per match will be followed throughout.

Individuals who wish to fire out of competition are welcome to participate up to range capacity for the match (36 shooters).

**MATCH #4:** Aggregate of Matches 1-3.
