FIRING WILL COMMENCE AT 9:00 a.m.

OBJECTIVE: To introduce shooters to long-range Rimfire prone competition

RULES: Rules will be set at Match Director's discretion, though we will comply with general NRA rules for prone shooting for the conduct of the match. (Pertinent NRA rules will apply for use of electronic targets.)

RIFLES ALLOWED: **Caliber restricted to 22LR ONLY.** Rifle categories will include: Sling supported/Iron sights, Sling Supported/Optical Sights, Rimfire F-T/R (bipod supported), and Rimfire F-Open (Front rest supported). No compensators or muzzle brakes allowed – Rule 3.16.1

TARGETS: NRA MR52 (for all competitors, sling and F-Class). (Hexa Electronic targets will be used)

CLASSIFICATION: As this is a non-sanctioned event, no classification records are necessary

CATEGORIES: Minimum of 5 shooters required to form a class/category (based on rifle type).

SQUADDING: **At Statistical Office commencing at 8:00 a.m.**

Prepaid entries will be squadded first. Entries made by telephone cannot be guaranteed.

Competitors are required to check in by 8:45 a.m.

Entries end at 8:50 a.m. the day of the match and are restricted to the first 60 paid competitors.

GENERAL: *The Match Director is authorized to reduce the match in shots fired or distance due to range conditions.*

Competitors will be required to serve as score keepers.

Refunds will not be provided once the match has commenced.

REGISTRATION: **ON-LINE PRE-REGISTRATION IS STRONGLY ENCOURAGED.**
