TARGETS: NRA C3 Target (300 Meter reduced to 300 Yards). (Hexta Electronic targets will be used)

**CLASSIFICATION:** As this is a non-sanctioned event, no classification records are necessary

**CATEGORIES:** Minimum of 5 shooters required to form a class/category (based on rifle type).

SQUADDING: At Statistical Office commencing at 8:00 a.m.

Prepaid entries will be squadded first. Entries made by telephone cannot be guaranteed. Competitors are required to check in by 8:45 a.m. Entries end at 8:50 a.m. the day of the match and are restricted to the first 48 paid competitors.
