**FIRING WILL COMMENCE AT 9:00 a.m.**

**OBJECTIVE:** To introduce shooters to the 300 Meter International Prone Shooting discipline

**RULES:** Rules will be set at Match Director's discretion, though we will comply with current NRA International Rifle rules to the extent practicable. General NRA rules will govern the conduct of the match. (Pertinent NRA rules will apply for use of electronic targets.)

**RIFLES ALLOWED:** Rifles will include 300 Meter Free Rifle, 300 Meter Standard Rifle. Palma Rifle, Any Rifle/Iron Sight, Any Rifle/Any Sight. No compensators or muzzle brakes allowed – Rule 3.16.1

**TARGETS:** NRA C3 Target (300 Meter reduced to 300 Yards). (Hexa Electronic targets will be used)

**CLASSIFICATION:** As this is a non-sanctioned event, no classification records are necessary

**CATEGORIES:** Minimum of 5 shooters required to form a class/category (based on rifle type).

**SQUADDING: At Statistical Office commencing at 8:00 a.m.**

Prepaid entries will be squadded first. Entries made by telephone cannot be guaranteed.

Competitors are required to check in by 8:45 a.m.

Entries end at 8:50 a.m. the day of the match and are restricted to the first 48 paid competitors.

**GENERAL:** *The Match Director is authorized to reduce the match in shots fired or distance due to range conditions.*

*Competitors will be required to serve as score keepers.*

*Refunds will not be provided once the match has commenced.*
