### **FIRING WILL COMMENCE AT 9:00 AM ON BOTH DAYS**

**RULES:** Current NRA rules will govern the conduct of the match. (Pertinent NRA rules will apply for use of electronic targets.)

**ELIGIBILITY:** NRA membership is not required to compete in NRA sanctioned matches, although it is strongly encouraged. State Champion status will be awarded to the **Delaware resident** holding the 2-Day aggregate high score in Conventional Prone, F-T/R, and F-Open **PROVIDED** competitor is a member of DSSA.

**RIFLES ALLOWED:** Service Rifle - Rule 3.1; Any Rifle – Rule 3.2; NRA Match Rifle – Rule 3.3; Palma Rifle - Rule 3.3.1; F-Class Rifle - Rule 3.4 (a), (b) ; Midrange (prone) Tactical Rifle (AR) Rule 3.3.3. No compensators or muzzle brakes allowed – Rule 3.16.1

**TARGETS:** MR1/FC (600 yards.) as appropriate (Hexa Electronic targets will be used.)

**CLASSIFICATION:** NRA Mid-Range/F-Class classification cards, or temporary score books are required.

**CATEGORIES:** Minimum of 5 shooters required to form a class/category.

**SQUADDING:** At Statistical Office commencing at 7:30 a.m.

Prepaid entries will be squadded first. Entries made by telephone cannot be guaranteed.

Competitors are required to check in by 8:15 a.m.

Entries end at 8:30 a.m. the day of the match and are restricted to the first 60 paid competitors.

### **GENERAL:**

*The Match Director is authorized to reduce the match in shots fired or distance due to range conditions.*

*Competitors will be required to serve as score keepers.*

*Refunds will not be provided once the match has commenced.*

## **COURSE OF FIRE:**

### **Day 1:**

**MATCH #1:** 600 yard slowfire; Unlimited sighters, 20 record rounds, time limit 22 minutes.

**MATCH #2:** 600 yard slowfire; 2 sighters, 20 rounds for record, time limit 22 minutes.

**MATCH #3:** 600 yard slowfire; 2 sighters, 20 rounds for record, time limit 22 minutes.

**MATCH #4:** **Aggregate of Matches 1-3.**

### **Day 2:**

**MATCH #5:** 600 yard slowfire; Unlimited sighters, 20 record rounds, time limit 22 minutes.

**MATCH #6:** 600 yard slowfire; 2 sighters, 20 rounds for record, time limit 22 minutes.

**MATCH #7:** 600 yard slowfire; 2 sighters, 20 rounds for record, time limit 22 minutes.

**MATCH #8:** **Aggregate of Matches 5- 7.**

**MATCH #9:** **Grand Aggregate of Matches 4 and 8.**
