MATCH #3: Aggregate of Matches 1 and 2.

Two Man Team Match, Day 1:

MATCH #T1: 600 yard Team Match. 2 sighting shots, 20 rounds for record, time limit 50 minutes per

team.

Individual Match, Day 2:

MATCH #4: 600 yard slow fire. Unlimited sighting shots, 20 rounds for record, time limit 22 minutes.

MATCH #5: 600 yard slow fire. 2 sighting shots, 20 rounds for record, time limit 22 minutes.

MATCH #6: Aggregate of Matches 1 and 2.

Two Man Team Match, Day 2:
