MATCH DATES: Saturday, October 26th, and Sunday, October 27th

FIRING WILL COMMENCE AT 8:30 a.m.

RULES: Current NRA rules will govern the conduct of the match. (Pertinent NRA rules will apply for use of electronic targets, when available.)

ELIGIBILITY: NRA membership is not required to compete in NRA sanctioned matches, although it is strongly encouraged.

RIFLES ALLOWED: Palma Rifle - Rule 3.3.1(a) & (b); F-Class- Rule 3.4 (a), (b). Note: The Service Rifles M14 and M16/M110 with iron sights fall within rules 3.3.1(a) and (b). Iron sights only are allowed on all rifles. Competitors shooting Any Rifle/Any Sight are welcome, but are not eligible for Palma Awards. Squadding preference will be to Palma Rifle shooters. No compensators or muzzle brakes allowed – Rule 3.16.1

TARGETS: LR, LR/FC as appropriate. (Hexa Electronic targets will be used)

CLASSIFICATION: NRA Long Range/F-Class classification cards, or temporary score books are required.

CATEGORIES: Minimum of 5 shooters required to form a class/category.

SQUADDING: At Statistical Office commencing at 7:00 a.m.

Prepaid entries will be squadded first. Entries made by telephone cannot be guaranteed.

Competitors are required to check in by 8:00 a.m.

Entries end at 8:15 a.m. the day of the match and are restricted to the first 60 paid competitors.

GENERAL: *The Match Director is authorized to reduce the match in shots fired or distance due to range conditions.*

Competitors will be required to serve as score keepers.

Refunds will not be provided once the match has commenced.

DEPOSIT: \$10.00 deposit received prior to the match will hold entry. Shooter should call prior to match date to confirm receipt. Deposit may be forfeited if shooter fails to notify club of cancellation prior to match date.

AWARDS: Awards will be given in each category and class. Awards will be given to each multiple of 5 competitors in each category. Competitors may not win more than one award in each match. Classes and/or categories will be combined at the discretion of the match director.

ENTRY FEE: \$30.00/Day

CHALLENGES: \$2.00 per challenge LOST.

MATCH DIRECTOR: Frank Nedza

CAMPING SPACE: Available at the range. Electrical connections are available.

PRACTICE: Individuals will be able to practice along with the Palma Match competitors, up to range capacity. Palma Match competitors will have priority for available target positions.

COURSE OF FIRE:

Match #1: 800 yd. slow fire, unlimited sighters, 15 rounds for record. Time: 22 min.

Match #2: 900 yd. slow fire, 2 sighters, 15 rounds for record. Time: 22 min.

Match #3: 1000 yd. slow fire, 2 sighters, 15 rounds for record. Time: 22 min.

Match #4: Aggregate of Matches 1-3

Match #5: 1000 yd. slow fire, Unlimited sighters, 20 rounds for record. Time: 33 min

Match #6: Aggregate of Matches 4 and 5

COURSE OF FIRE: Day TWO –October 27th ONLY

Match #7: 800 yd. slow fire, unlimited sighters, 15 rounds for record. Time: 22 min.

Match #8: 900 yd. slow fire, 2 sighters, 15 rounds for record. Time: 22 min.

Match #9: 1000 yd. slow fire, 2 sighters, 15 rounds for record. Time: 22 min.

Match #10: Aggregate of Matches 7-9
